Vendors agree to abide by the following terms:

Vendors agree to accept the space and location assigned to them. Vendors may not change spaces/locations unless authorized to do so by the Sidewalk Sale Chairperson. **Vendors who wish to use a tent must make this request in advance.** Requests will be handled on a first-come/first-served basis. **You will not be given a “tent accessible” location unless one is requested on this application, and accommodations will not be made on the day of the sale.**

Special requests, such as site assignments, must be submitted in writing with this application. Every effort will be made to fulfill a request, but **there is no guarantee that all requests will be met.**

Priority will be given to vendors who participate in all 3 days of the sale. Vendors who fail to show up without prior notice or who are not in their space by the start of the sale will have their spaces reassigned.

The Lincoln Square Chamber does not provide for overnight storage or security. **For the sake of safety and permit compliance all vendors must tear down each evening.**

Absolutely no refunds after June 16, 2006. The Sidewalk Sale will take place rain or shine.

The Lincoln Square Chamber, at its sole discretion, reserves the right to deny or withdraw immediately the participation of any vendor.

Lincoln Avenue merchants who do not plan to have merchandise on the sidewalk and do not pay the appropriate fee will find sidewalk space in front of their stores assigned to fee-paying vendors.

This is not a “street fair” therefore space in the street for display or use of any kind is not permitted.

Food vendors agree to abide by all City of Chicago health code rules during the Sidewalk Sale. No vendor will disobey any regulation of the City of Chicago or any directive of the Chamber of Commerce, Police or Fire Department.

The Lincoln Square Chamber reserves the right at its sole discretion, to prohibit any person or group from distributing leaflets or literature at the Sidewalk Sale.

The Lincoln Square Chamber reserves the right to limit the number of spaces to any one vendor. The Lincoln Square Chamber, at its sole discretion, reserves the right to limit the number of vendors in any single category or product or service.

The Lincoln Square Chamber is an equal opportunity entity and does not discriminate on the basis of race, creed, color or sexual orientation.

I hereby agree to offer for sale at the Lincoln Square “Sidewalk Sale” only such items as are listed on this application. Further, I agree to read and totally abide by the Sidewalk Sale rules and regulations, and acknowledge full responsibility for all activities conducted throughout the term of this permit. I additionally agree to hold the Lincoln Square Chamber of Commerce harmless and to indemnify the Lincoln Square Chamber of Commerce for any and all claims of whatever kind of nature, which might be made against the Lincoln Square Chamber of Commerce due to my participation in the Sidewalk Sale.
